ALLOW 5 BUSINESS DAYS FOR PROCESSING, AND ADDITIONAL TIME FOR MAIL DELIVERY. Speedy mail delivery is not guaranteed. If registration is needed within 2 weeks, registering in person at a registration agent is recommended.
